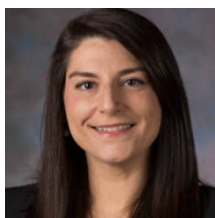

Keynote Speaker: Bruce T. Vanderhoff, M.D., M.B.A.



The Director of the Ohio Department of Health, Dr. Bruce Vanderhoff, will offer his perspective on the future of lead poisoning prevention in Ohio. He will talk about the measures and methods the Department of Health utilizes to combat lead poisoning, how the work is progressing and important considerations on how the landscape can be improved.

Learning goals: Participants should gain clear understanding of the scope of the lead poisoning problem in Ohio, the challenges in addressing the crisis, where Ohio stands regarding its response and the promising approaches that can be taken toward advancing the health of children regarding lead poisoning.

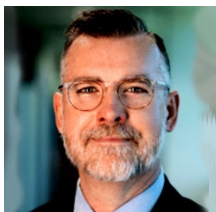

They will discuss the tools they provide to local communities and resources they provide to families to address the problem of lead poisoning. They will discuss issues such as blood testing for lead, lead hazard control orders, Lead Safe Home Fund grant opportunities, contracting certification and licensing, workforce development and more.

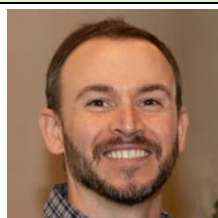

They will also receive more guidance in identifying resources that the departments have available to assist communities and individuals in addressing lead poisoning issues.

10:20 a.m.	Breakout 2 (Franklin/Hamilton Room): Healthcare with Roopa Thakur, M.D., F.A.A.P.: Lead as a Social Determinant of Health and an Environmental Justice Issue
	<p>Dr. Thakur will discuss her professional experiences in treating children suffering from lead poisoning and her perspectives on the healthcare response to the problem. She will discuss the challenges in the healthcare industry regarding its lead response and the health implications; share data to illustrate the scope, effects, and trends; and discuss ways of improving the healthcare response to both prevent elevated blood lead levels and to provide more clinical services to children suffering from lead poisoning. She will also offer perspectives about provider, health system and local community collaboration.</p> <p><i>Learning goals:</i> Participants will develop an understanding of the importance of linking stronger quality control measures to the delivery of care to children suffering from or exposed to lead poisoning. They will learn the limitations of the current healthcare delivery system and ideas to improve it to drive a higher standard of care for patients poisoned by lead. They will develop an understanding of lead poisoning as a social determinant of health.</p>

Jacobs, Ph.D., C.I.H.</p> <div>  </div> <p>David Jacobs will give a talk on the “Evolution of Lead Poisoning Prevention in America.” He will provide a timeline of the healthcare response to the lead poisoning crisis and insight into the decisions that have been made along the way. He will discuss how different approaches have been deployed, what has been learned from those decisions and how we have progressed to date. He will offer alternatives regarding how society responds to this crisis in the future.</p> <p><i>Learning goals:</i> Participants will gain a historical perspective of the lead problem in America and an understanding of various decisions that have impacted both government policy, as well as, decisions and best practices that have shaped the lead poisoning prevention policies and practices used today.</p>

Learning goals: Participants will hear how several different collaboratives were formed, how they operate and how they vary based on their current missions.

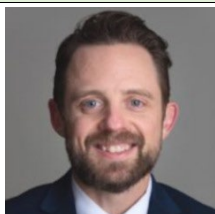

He will also expand upon concepts such as priorities, capacity and performance and the relationship between funders and grantees.

This dialogue will give important direction to organizations that need to align their funding requests with their vision, mission and capacity.
